# ITG Strategy 2022 - 2030

Vision: Being a long-term competence partner to Mongolia and all countries in the original homeland of takhi in Central Asia in order to conserve and, where appropriate, help to create ecological networks of protected areas for the reintroduction and conservation of takhi and its habitat.

#### Mission:

- 1. Supporting governments and other relevant bodies to build up self-sustainable takhi populations in Central Asia in order to develop a long-term perspective for the takhi in its original homeland;
- 2. Supporting governments and other relevant bodies in conservation and management of protected areas in Central Asia with a focus on takhi and reflections on the socio-economic issues of local communities;
- 3. Strengthen the capacity of Mongolian authorities to safeguard the takhi population in Great Gobi B SPA and thus accomplish the reintroduction project by 2030;
- 4. Collaborating with scientific institutions to initiate, support and conduct research activities on takhi and the species community sharing the same habitat as a base for conservation and management;
- 5. Promoting and facilitating national and international cooperation between partners in takhi conservation in Central Asia.
